Applicants are advised to read all instructions carefully before sending their applications.

A. Benefits under MDNIY service:

1. The post carry usual allowance as admissible to the Central Government Employees and as made applicable to Morarji Desai National Institute of Yoga (MDNIY) employees.
2. Medical facilities is available to employees of MDNIY as per Central Services (MA) Rules 1944 as amended from time to time.

B. Other Conditions:

1. The applicant must be a citizen of India.
2. All applicants must fulfill the essential requirements of the post and other conditions stipulated in the advertisement as on the last date of receipt of the applications. They are advised to satisfy themselves before applying that they possess essential criteria laid down for various posts. No enquiry asking for advice as to eligibility will be entertained.
3. In case of posts to be filled through deputation, the pay of the Officer selected for appointment on deputation basis will be regulated in accordance with the Government Rules. The Officers desirous of being considered for the post should apply through proper channel. Their applications for deputation may be forwarded along with the applicants' duly verified personal Bio-data as per proforma enclosed with this advertisement along with Cadre Clearance, Vigilance Clearance and attested photo copies of ACRs/APARs for the last five. The authorities forwarding the applications should certify that in the case of selection, the officer would be relieved immediately.
4. The prescribed essential criteria is minimum and mere possession of the same does not entitle candidates to be called for screening/interview. The Competent Authority reserves the right to shortlist candidates on the basis of higher qualifications/year of experience in the subject/screening test/other criteria. The decision of the Director, Morarji Desai National Institute of Yoga (MDNIY) will be final in this regard.
5. The period of experience rendered by a candidate on part time basis, daily wages, visiting/guest faculty will not be counted while calculating the valid experience.

6. If any document/certificate furnished in a language other than Hindi or English, a transcript in Hindi/English of the same duly attested by a Gazetted Officer or Notary is to be submitted.
7. The date for determining the upper age limit, qualification and/or experience will be the closing date prescribed for receipt of application.
8. Age limit for direct recruitment is relaxable upto 5 years for candidates belonging to SC/ST community and Govt./Autonomous Body employees and upto 3 years for candidates belonging to OBC community in accordance with orders issued by the Central Govt. from time to time.
9. Vacancies and reservation status will be applicable as per this notification. However, vacancies may increase or decrease at the time of screening/interview by the order of the Competent Authority. This is subject to change without any notice.
