AGENDA ITEM NO.01:

OF THE 46th MEETING OF THE CONFIRMATION OF MINUTES STANDING FINANCE COMMITTEE OF MONIY HELD ON 24TH MAY, 2022.

Director, MDNIY informed that the minutes of 46th Meeting of the standing Finance Committee of MDNIY, held on 24.05.2022, were circulated to all the members of the SFC. Since no comments have been received from any of the members, the minutes of the 46th meeting of the SFC held on 24.05.2022 were confirmed.

ACTION TAKEN REPORT ON THE DECISIONS TAKEN IN THE 46TH MEETING OFTHE SFC HELD ON 24.05.2022.

Action Taken Report on the minutes of the 46th Meeting of SFC held on 24.05.2022 was discussed and noted.

AGENDA ITEM NO.03:

TO CONSIDER AND APPROVE THE REVISED ESTIMATE (RE) 2022-23 AND BUDGET ESTIMATE (BE) 2023-24 IN RESPECT OF MDNIY.

Director, MDNIY informed that RE 2022-23 and BE 2023-24 were discussed with the officials of budget section of Ministry of Ayush. After detailed discussion, SFC of MDNIY recommended the proposal for the revised estimates (RE) 2022-23 (Rs.74.50 crores) and budget estimates 2023-24(Rs.127.00 Crores) of the MDNIY.

AGENDA ITEM NO.04:

TO CONSIDER AND APPROVE TO ENGAGE THE CONSULTANTS, DOMAIN EXPERTS AND CONTRACTUAL STAFF AS PER THE GUIDELINES ISSUED BY THE MINISTRY OF AYUSH VIDE LETTER NO.A-41021/4/2020-E-II DATED 13.07.2021, AS AMENDED FROM TIME TO TIME.

Director, MDNIY informed that the engagement of consultants in MDNIY is being made as per the guidelines issued by the Ministry of Ayush vide letter No. A-41021/4/2020-E-II, dated 13.7.2021, as amended from time to time. As per the guidelines for the engagement of domain experts and senior consultants carrying a remuneration of Rs.75,000/-,proposals are being put up to the Ministry, where JS is the Chairperson. Since, the post of the Director, MDNIY, held by the present Director, was upgraded to the Pay Level 14 and the Directors of all National Institutes under the Ministry of Ayush are chairing the Selection Committees as per the guidelines of the Ministry of Ayush, as referred above Director, MDNIY has also informed that the engagements of consultants and their selection are being frequently being made in the MDNIY, and any delay in the selection procedure results in non-joining of the competent selected candidates. After detailed discussion, SFC has recommended:

To engage the consultants, domain experts and contractual staff at MDNIY as per the guidelines issued by the Ministry of Ayush vide letter No.A-41021/4/2020-E-II, dated 13.07.2021, as amended from time to time, and by following all codal formalities as per GFRs, 2017.

SFC was of the view that level of Chairperson is to be decided by the Ministry. SFC is not competent for it.

AGENDA ITEM NO.05:

TO CONSIDER AND APPROVE THE ENGAGEMENT OF ONE SENIOR CONSULTANT (YOGA EXPERT) IN THE OFFICE OF DIRECTOR, MDNIY, NEW DELHI, AND ONE SR. CONSULTANT (YOGA) FOR BUREAU OF INDIAN STANDARDS.

Director, MDNIY informed the SFC that after the Covid pandemic the activities related to Yoga therapy consultancy services, International Day of Yoga activities, production of audio visual aids, Yoga Protocol to various target groups have increased multiple times during the last year. Accordingly, Director, MDNIY office needs more technical persons to handle them independently to deliver these timely.

During the last year, the Yoga related work of BIS has also been very fruitful. However, there is a need to increase the pace of the present work and need more technical work to be completed in a time bound manner. Hence, there is a need to engage one senior consultant (Yoga).

The matter has been discussed at length. SFC recommended the engagement of two senior consultants (Yoga), one at the office of the Director, MDNIY and one senior consultant(Yoga) for the BIS related work as domain experts, initially for a period of one year, after obtaining approval of competent authority in accordance with GFRs, 2017 and further complying provisions of guidelines of Ministry of Ayush on engagement of consultants as well as following all codal formalities.

AGENDA ITEM NO.06:

TO CONSIDER AND APPROVE ENGAGEMENT OF 05 DISTIGUISHED VISITING FACULTIES.

The Director MDNIY explained that MDNIY is a national institute dedicated for promotion, training and research in Yoga. MDNIY is running PG, UG, PG Diploma and Diploma courses along with some short/long term certificate courses. MDNIY wishes to engage 5 distinguished visiting faculties from the field of Yoga Education (having knowledge of Yoga texts), Yoga Science (having knowledge of Yoga therapy and research), Yoga & Human Consciousness, Life Sciences, and Research Methodology. Each distinguished visiting faculty is proposed to be given an honorarium of Rs.5000/- per visit, maximum 10 visits per faculty/per month plus conveyance/TA as per Government norms.

The Chairperson, SFC was of the view that there is some DoPT guidelines, on the honorarium to be paid to the distinguished visiting faculties, which may be seen. The distinguished visiting faculties may be paid respectfully to get the best brain in the respective field. After the detailed discussion, the SFC recommended to:

The SFC discussed the proposal of MDNIY to strengthen the integrated Yoga Therapy Clinic (OPD) at MDNIY. It was informed to SFC that institute has got very good reputation for providing Yoga Therapy and training facilities at the Institute.

As experts from other streams are proposed in OPD services of MDNIY same may be submitted to Ministry for a policy decision in the matter.

AGENDA ITEM NO. 9:

TO CONSIDER AND APPROVE THE PROPOSAL TO CONDUCT AN ANNUAL EVENT- YOGA MAHOTSAV-2023, A CURTAIN RAISER FOR INTERNATIONAL DAY OF YOGA 2023 FROM 13-14 MARCH, 2023 & THE EXPENDITURE THEREIN.

Director, MDNIY informed that Yoga Mahotsav-A Curtain Raiser for International Day of Yoga is being organised in the month of March every year. This year, it is proposed to organise Yoga Mahotsava-2023 -A Curtain Raiser event for the IDY 2023 on 13-14 March, 2023 with an estimated expenditure of rupees one crore, which will be met out of the regular budget allocation to MDNIY, after adherence of the codal formalities.

The Director, IFD is of the view that in case any event involving an expenditure of more than 40 lakhs, prior approval of the Department of Expenditure shall be obtained. SFC discussed the proposal at length and placed on record its appreciation for organising the annual events Yoga Mahotsava and other IDY related events successfully by MDNIY.

After detailed discussion, SFC recommended the proposal and directed that a detailed proposal, complete in all respects, may be submitted to the Ministry of Ayush for examination and obtaining approval of the competent authority.

TO CONSIDER AND APPROVE THE DUBBING OF THE IDY COMMON YOGA PROTOCOL VIDEO (ENGLISH) 2022 OF MDNIY INTO 22 OFFICIAL LANGAUGES WITH AN ESTIMATED COST OF RS. 22.00 LAKH, EXCLUDING GST.

Director, MDNIY informed that the IDY Common Yoga Protocol Video (English) has been prepared in the Year 2022 and is in the public domain. Now this needs to be re-editing, including the glimpses of IDY 2022 and publishing in 22 official languages for the dissemination of the information to the common people.

The matter has been discussed at length and thereafter the SFC recommended the following, subject to approval of the competent authority:

(i) The editing of the IDY Common Yoga Protocol Video 2022 and updating it to dub IDYCYP in 22 official languages;

(ii) The video shall have two parts. Part-1 with the introduction and dos and don'ts (briefly) and part-II for Common Yoga Protocol of 45 minutes.

(iii) The rates of editing and dubbing in various languages shall be as per the instructions/rates of the DAVP, after following the codal formalities with the allocated budget of the MDNIY;

The Chairman, SFC has also instructed to prepare Yoga Break Yoga Protocol in sitting position and teaching modules for updating the Yoga Break App, which has been agreed. The said videos and teaching modules shall be prepared as per the DAVP approved rates after following codal formalities and the expenditure incurred therein shall be met out from the allocated budget of MDNIY..

AGENDA ITEM NO. 11:

TO CONSIDER AND APPROVE THE DUBBING OF SURYA NAMASKAR VIDEO 2022 (1-2 MINUTES) OF MDNIY INTO 22 OFFICIAL LANGUAGES WITH AN ESTIMATED COST OF RS. 7.70 LAKH EXCLUDING GST.

Director, MDNIY informed that the Surya Namaskar Video of two minutes duration needs to be dubbed in 22 official languages for the wider dissemination of the knowledge.

SFC recommended editing of the Surya Namaskar Video of 2 minutes duration and also dub it into 22 official languages at the DAVP rates with estimated expenditure of 8 lakhs + GST, after adherence to the codal formalities and obtaining approval of the competent authority.

AGENDA ITEM NO. 12:

TO CONSIDER AND APPROVE THE PROPOSAL FOR PUBLISHING THE 'YOGA VIJNANA: THE SCIENCE AND ART OF YOGA' FROM WOLTERS KLUWER/MEDKNOW TO IMPROVE THE QUALITY OF JOURNAL AND

The Director, MDNIY has explained the matter before the SFC for publishing the 'Yoga Vijnana: The Science and Art of Yoga' from Wolters Kluwer/Medknow to improve the quality of journal and signing of MoU with Wolters Kluwer/Medknow.

SFC discussed the matter at length and recommended for publication of "Biannual Journal Yoga Vijnana: The Science and Art of Yoga" after consultation with the Director, AIIA, Director CCRYN, Director Ayush. Shri Niret Kurian, Dy. Director MoA shall facilitate the meeting.

SFC also desired that the empanelment of the agency will be made after following the codal formalities as per GFRs, 2017.

After finalising the agency, the proposed expenditure on actual basis shall be put up on file for the approval of the competent authority.

AGENDA ITEM NO. 13:

TO CONSIDER AND APPROVE THE PURCHASING OF ROUTER FOR UPGRADATION OF MTNL LEASE LINE UPTO 01GBPS AT MIDNIY WITH AN ESTIMATED COST OF RS. 16.02 LAKH, INCLUDING GST.

SFC recommended to engage an agency which can provide two senior developers (01 for Namaste Yoga App and another for Ayush Yoga Portal),
