



TO REPORT ACTION TAKEN ON THE MINUTES OF THE 52<sup>ND</sup> MEETING OF STANDING FINANCE COMMITTEE OF MDNIY HELD ON 26.11.2024.

Director, MDNIY apprised the IFC in respect of action taken by the Institute on the Minutes of the 52<sup>nd</sup> SFC held on 26.11.2024. As regards agenda item No.3 of 51<sup>st</sup> SFC, Member Secretary apprised the IFC that the Committee has submitted its preliminary report regarding reviewing the existing posts, recruitment rules and promotional avenues to Director, MDNIY for further necessary action. Chairperson IFC directed that the report of the committee may be submitted to Ministry of Ayush on file for further necessary action at the earliest.
