जबकि श्री अनुराग, निवासी अथिरा निवासरा-122बी, भुवनेश्वरी मंदिर, रोडपेट्टा, एर्नाकुलम के द्वारा आरटीआई अधिनियम के तहत सीपीआईओ, मोरारजी देसाई राष्ट्रीय योग संस्थान, नई दिल्ली-110001 को एक आरटीआई आवेदन प्रस्तुत किया गया था।

Whereas a RTI Application was submitted by Shri Anurag, a resident of Athira Nivasra-122B, Bhuvaneswari Temple, Roadpetta, Ernakulam under the RTI Act to the CPIO, Morarji Desai National Institute of Yoga, New Delhi-110001.

2. जबकि सीपीआईओ, मोरारजी देसाई राष्ट्रीय योग संस्थान ने अपने आदेश संख्या 11-369/2023-स्था. दिनांक 17.2.2025 के माध्यम से आवेदन का फैसला किया, वांछित जानकारी प्रदान की और आरटीआई आवेदन का फैसला किया।

2. Whereas the CPIO, Morarji Desai National Institute of Yoga decided the application vide his Order No11-369/2023-Estt., dated 17.2.2025, provided the desired information and decided the RTI Application.

3. जबकि सीपीआईओ, मोरारजी देसाई राष्ट्रीय योग संस्थान के आदेश दिनांक 17.2.2025 से व्यथित होकर, श्री अनुराग ने उपर्युक्त अपील दायर की। आवेदक ने सरकारी कॉलेज ऑफ फिजिकल एजुकेशन, ईस्ट हिल, कोझीकोड, केरल में आयोजित अंतर्राष्ट्रीय योग दिवस 2023 की उल्टी गिनती कार्यक्रम से संबंधित कुछ जानकारी मांगी है। इस संबंध में यह देखा गया है कि सीपीआईओ ने अपने पत्र संख्या 11-369/2023-स्था. दिनांक 17.2.2025 के माध्यम से अपीलकर्ता को आधिकारिक रिकॉर्ड के अनुसार प्रासंगिक उपलब्ध जानकारी प्रदान की है। अब आवेदक सीपीआईओ से प्राप्त उत्तर से असंतुष्ट है, इसलिए श्री अनुराग ने पंजीकरण संख्या एमडीआईवाईओ/ए/ई/25/00001, दिनांक 22.2.2025 के तहत प्रथम अपील दायर की है।

3. Whereas aggrieved by the Order dated 17.2.2025 of the CPIO, Morarji Desai National Institute of Yoga, Shri Anurag filed the above mentioned appeal. The applicant has sought certain information relating to the countdown programme to International Day of Yoga 2023 organized at Government College of Physical Education, East Hill, Kozhikode, Kerala. In this regard it is observed that the CPIO has provided the relevant available information as per the official record to the appellant vide his letter No11-369/2023-Estt. Dated 17.2.2025. Now the applicant being dissatisfied with the reply received from the CPIO, MDNIY has filed a First Appeal Vide Registration No. MDIYO/A/E/25/00001, dated 22.2.2025.


4. जबकि नीचे हस्ताक्षरकर्ता ने प्रथम अपील की विषय-वस्तु का अध्ययन करने तथा आरटीआई अधिनियम, 2005 के प्रावधानों के आलोक में इसकी सावधानीपूर्वक जांच करने के पश्चात पाया है कि अपीलकर्ता ने अपनी प्रथम अपील में व्यक्तिगत राय दी है तथा उसका औचित्य मांगा है। इस प्रकार नीचे हस्ताक्षरकर्ता की राय है कि आरटीआई अधिनियम, 2005 के प्रावधानों के अनुसार एक सार्वजनिक प्राधिकरण को आधिकारिक रिकॉर्ड में उपलब्ध जानकारी प्रदान करनी होती है तथा वह अपीलकर्ता की व्यक्तिगत राय का उत्तर या प्रतिक्रिया नहीं दे सकता है या प्रदान की गई जानकारी के बदले में औचित्य प्रदान नहीं कर सकता है। रिकॉर्ड में उपलब्ध जानकारी सीपीआईओ द्वारा अपीलकर्ता को पहले ही प्रदान कर दी गई है। इसलिए, अपील का निपटारा किया जाता है।

4. Whereas the undersigned, after going through the contents of the first appeal and after its careful examination in the light of the provisions of the RTI Act, 2005, has observed that the appellant has suggested personal opinions in his first appeal and sought justification thereto. The undersigned is thus of the opinion that in terms of the provisions of the RTI Act, 2005 a Public Authority is to provide information as available in official record and cannot answer or respond to the personal opinions of the appellant or provide justification in lieu of the information provided. The information, as is available on record, has already been provided to the appellant by the CPIO. Hence, the appeal stand disposed of.

जबकि डॉ. एच.के. राजपाल, मोहल्ला शिवगंज, करशदेव मंदिर के पास, औरानीपुर, झांसी, उत्तर प्रदेश द्वारा आरटीआई अधिनियम के तहत नोडल अधिकारी, आयुष मंत्रालय को पंजीकरण संख्या आयुष/आ/ई/25/00135, दिनांक 27.2.2025 के तहत आरटीआई आवेदन प्रस्तुत किया गया था।

Whereas a RTI Application was submitted by Dr. HK Rajpal, Mohalla Shivganj, Near Karashdev Temple, Auranipur, Jhansi, UP under the RTI Act to the Nodal Officer, Ministry of Ayush vide Registration No. Ayush/R/E/25/00135, dated 27.2.2025.

2. जबकि नोडल अधिकारी, आरटी, आयुष मंत्रालय ने दिनांक 27.2.2025 के उक्त आरटीआई आवेदन को सीपीआईओ, मोरारजी देसाई राष्ट्रीय योग संस्थान को दिनांक 3.3.2025 को स्थानांतरित कर दिया और सीपीआईओ, एमडीएनआईवाई ने अपने आदेश दिनांक 18.3.2025 के माध्यम से आरटीआई का निपटारा कर दिया। अपने आदेश में सीपीआईओ ने स्पष्ट रूप से उल्लेख किया था कि मांगी गई जानकारी मोरारजी देसाई राष्ट्रीय योग संस्थान से संबंधित नहीं है और आरटीआई आवेदन को योग प्रमाणन बोर्ड को अग्रप्रेषित करते हुए उल्लेख किया कि इसे योग प्रमाणन बोर्ड से प्राप्त किया जा सकता है। इसलिए, आरटीआई आवेदन को आवश्यक कार्रवाई के लिए वाईसीबी को भेज दिया गया।


2. Whereas the Nodal Officer, RT, Ministry of Ayush transferred the said RTI Application dated 27.2.2025 to the CPIO, Morarji Desai National Institute of Yoga on 3.3.2025 and the CPIO, MDNIY disposed of the RTI vide his Order dated 18.3.2025. In his order the CPIO had clearly mentioned that the information sought does not pertain to the Morarji Desai National Institute of Yoga and while forwarding the RTI Application to the Yoga Certification Board mentioned that the same can be obtained from the Yoga Certification Board. Hence, the RTI application was forwarded to the YCB for necessary action.

3. जबकि सीपीआईओ, मोरारजी देसाई राष्ट्रीय योग संस्थान के दिनांक 18.3.2025 के आदेश से व्यथित होकर, डॉ. एच.के. राजपाल ने उपर्युक्त अपील दायर की। अपीलकर्ता ने अपनी अपील में कहा है कि उनके आवेदन को आरटीआई अधिनियम 2025 की धारा 6III के तहत संबंधित प्राधिकारी को भेजा जाना चाहिए था।

3. Whereas aggrieved by the Order dated 18.3.2025 of the CPIO, Morarji Desai National Institute of Yoga, Dr. HK Rajpal filed the above mentioned appeal. In his appeal the appellant has submitted that his application should have been forwarded to concerned authority under Section 6III of RTI Act 2025.

4. जबकि, दिनांक 27.2.2025 के आरटीआई आवेदन, अपीलकर्ता की दिनांक 19.3.2025 की अपील और सीआईपीओ के दिनांक 18.3.2025 के सीपीआईओ के आदेश के अवलोकन से यह पाया गया है कि मांगी गई सूचना मोरारजी देसाई राष्ट्रीय योग संस्थान से संबंधित नहीं है और इसलिए सीपीआईओ, एमडीएनआईवाई द्वारा आरटीआई आवेदन को संबंधित संगठन यानी वाईसीबी को सही तरीके से भेजा गया है। वाईसीबी एक अलग संगठन है जिसका अपना सीपीआईओ है और मांगी गई सूचना उनसे प्राप्त की जा सकती है। इसलिए, अपील का निपटारा किया जाता है।



Whereas, on perusal of the RTI application dated 27.2.2025, the Appeal dated 19.3.2025 from the Appellant and the Order of the CPIO dated 18.3.2025 of the CPIO it is observed that the information sought does not pertain to Morarji Desai National Institute of Yoga and hence the RTI application has rightly forwarded by the CPIO, MDNIY to the concerned organization, i.e. YCB. The YCB is a separate organization having their own CPIO, and the information sought can be obtained from them. Hence, the appeal stand disposed of.

Sub: First Appeal Registration No. MDIYO/A/E/24/00012, dated 29.10.2024 submitted by Shri Saurabh Singh, resident of Kailash Vihar, Awas Vikas No.1, MIG 336, Kanpur-208017.

Whereas a RTI Application vide Registration No. MDIYO/R/T/24/00034, dated 4.10.2024 was filed by Shri Saurabh Singh, resident of Kailash Vihar, Awas Vikas No.1, MIG 336, Kanpur-208017 before the Nodal Officer, Ministry of Ayush and the same was transferred on 7.10.2024 to the CPIO, Morarji Desai National Institute of Yoga, New Delhi. In his RTI application it was submitted that he is planning to open a therapy center in Jalandhar(Punjab) and hence sought details (1) where to Register his therapy centre and (2) what kind of Ayurvedic, Yogic and Naturopathic therapies he can provide.

2. Whereas the said RTI Application dated 7.10.2024 was disposed of by the CPIO, Morarji Desai National Institute of Yoga vide his order dated 29.10.2024 saying that the information sought does not pertain to Morarji Desai National Institute of Yoga(MDNIY).

3. Whereas aggrieved by the Order dated 29.10.2024 of the CPIO, Morarji Desai National Institute of Yoga, Shri Saurabh Singh filed the first appeal stating that he is planning to open a Naturopathy, Ayurvedic and Yoga center in Jalandhar(Kapurthala), Punjab and he want to know where to register his centre and what kind of therapies he can perform in his centre as a diploma holder.

4. Whereas, on perusal of the RTI application dated 7.10.2024, the Appeal dated 29.10.2024 and the order dated 29.10.2024 of the CPIO it is observed that the CPIO has rightly decided the case. Hence the appeal is disposed of with this observation.

5. If the Appellant is not satisfied with this order, under Section 19(3) of the RTI Act, he can file a second appeal before the Central Information Commission within 90 days from the date of receipt of this Order by Appellant.

Whereas an RTI application vide Reference AYUSH/R/E/24/0003000362/1 was received on 24.5.2024 in the Ministry of Ayush and the same was transferred by the Ministry of Ayush to Morarji Desai National Institute of Yoga vide RTI registration No.MDIYO/R/T/24/00018, dated 24.5.2024.

2. Whereas the CPIO, Morarji Desai National Institute of Yoga on decided the RTI vide letter dated 24.6.2024.

3. Whereas aggrieved by the said decision dated 24.6.2024 of the CPIO, the applicant wrongly filed an appeal No. AYUSH/A/E/24/00026, dated 3.6.2024 in the Ministry of Ayush and the same was transferred by the Ministry of Ayush to the Morarji Desai National Institute of Yoga vide letter No.M-12039/14/2024-YN, dated 13.7.2024.

4. I have carefully gone through the contents of the RTI Application and the reply sent by the CPIO and it has been observed that there is no flaw in the reply of the CPIO. The RTI Applicant has sought information from MDNIY, which is not available or kept by the Morarji Desai National Institute of Yoga. Under Section 6 of the RTI Act, an applicant is entitled to get only such information which is held by the public authority. The CPIO of MDNIY does not have access to the information sought and hence vide his Order dated 24.6.2024 he has rightly decided the RTI.

5. Therefore, the Appeal dated 3.6.2024 filed by Shri Inderpal is disposed off.

6. If the Appellant is not satisfied with this order, under Section 19(3) of the RTI Act, he can file a second appeal before the Central Information Commission within 90 days from the date of receipt of this Order by Appellant.






